In this context, EuroDEMOS is the coordinator the project Social Promoters of inclusiOn thRough sporT that is aiming to increase the inclusion of young people with fewer opportunities at European level through sporting activities.

The project Social Promoters of inclusiOn thRough sporT will be implemented between 01 October 2019 - 30 September 2020 and is co-funded by the Erasmus+ Programme of the European Union.

The project willing to achieve the following objectives:

- To train 30 youth workers from 10 countries as resource persons in working with persons with fewer opportunities;
- To develop 15 non-formal methods of increasing the inclusion of young people with fewer opportunities through sports activities;
- To develop the organizational strategies of the 10 partners with activities in the field of social inclusion of young people through sports activities.

The project Social Promoters of inclusiOn thRough sporT will include $\mathbf{2}$ mobilities which will take place in Iasi, Romania on 12 - 19 March 2020, 15 - 22 May 2020 and the 30 participants will represent the 10 partners from 10 countries.
!!!NOTE: We mention that 12 March and 15 May are arrival days and 19 March and 22 May are departure days.

The two trainings will be complementary in order the develop the youth workers with new knowledge, ideas, competences, practical methods of social inclusion of young people through sport, from the understanding of concepts to application, from receiving information to their transformation through creativity and innovation in intellectual products, from creation to receiving evaluation feedback, from design to practice, from working on national teams to working in multinational teams, from learning from others to their own initiatives, from information to dissemination. Both trainings will be based on the transmission of information by trainers, on the exchange of ideas and best practices among participants, on the involvement of participants in practical activities, on direct interaction with social actors and young people from the local community.

The trainings will be implemented through non-formal methods such as: ice breaks, team building, presentations, brainstorming, brain writing, workshops, inputs, sports dance as inclusion method, conflict
management, competitively method with youth with autism, application of methods designed by the participants and others.

The first training includes Erasmus + Presentation sessions to promote its importance and to have initiative for future projects. The Youthpass certificate and the 8 key competences will also be presented, each day being in the agenda time for reflection on their development. In the second mobility, the participants will work in multinational teams on concrete ideas of future Erasmus+ projects.

Among the results of the project we mention: the resource people for the 10 promoters, local youth and sports studies, the organizational strategies developed on the social inclusion through sport, the booklet with 15 non-formal methods, the video with the results of the project etc.

The youth workers will develop within an international frame their personal, social and professional competences as future trainers and project managers. The participants, through the 15 non formal methods that will be included in the booklet will have concrete tools with which can work efficiently to include youth with fewer opportunities through valuing the common language and the dynamic of sport activities.

As a long-term impact, the project aims to develop the capacity of the participants and promoters to organize local / national / international youth projects specifically addressing the social inclusion of young people through sport.
